MENTIONS ON ADMISSION TO A HIGHER YEAR OF STUDIES

Documents required for the equivalence of academic studies for admission to the higher year

- proof of schooling with the results of the passed exams with the signature and stamp of the issuing unit (diploma supplement/ school transcripts/ schooling certificate), signed and stamped
- the syllabus for each studied subject with the signature and stamp of the issuing unit.
- ◄ the official explanatory note on the grading system applied in the educational unit where he/she studied and the correspondence of this system with the European Credit Transfer System (ECTS) issued by the educational unit where he/she studied
- written application stating the year of study for which equivalence is requested, as well as
 the applicant's contact details: e-mail, telephone number, address.
- ■language certificate for the study program which he / she applies for
- documents written in a language other than Romanian must be translated into Romanian (legalised translation) or in the language of the study program which the application is submitted for
- proof of payment of the file processing fee:
 - 300 RON for Romanian citizens,
 - 1600 RON for Romanian citizens with degrees awarded in another country
 - 1600 RON for citizens of the European Union Member States, of the States from the European Economic Area, and of the Swiss Confederation
 - 1600 RON for third EU countries
- the deadline for submitting the complete files, in paper format, at the secretariats of
 the faculties located on 86 Liviu Rebreanu street, Arad Romania or for sending by email is
 July 20, 2023, or, for the seats remaining available, September 01-10, 2023:

Important Mentions

- ◄ Credit units are recognized, checked for equivalence, and transferred for the purpose of the
 possible continuation of studies from one study program to another or between higher
 education institutions in which the following requirements are cumulatively fulfilled:
- higher education institutions are institutionally accredited;
- study programs have the same qualification level in the European Qualifications Framework;
- study programs are in the same fundamental field;
- study programs lead to similar learning competencies / outcomes;
- For students wishing to be admitted to the second or third year of study, the equivalence of studies and the establishment of the year of study in which they can enrol, subject to passing the admission exam, will take into account the compatibility of curricula and will consider the transfer credit system, the minimum number of credit units for the recognition of a year of study being 45 for the programs within the Health field, except for the Pharmacy study program where the admission in higher year can be made only for the second year of study, transfer credit units awarded within the same program of studies delivered by another University.
- Students wishing to be admitted in the 4th, 5th, or 6th year of study within the study programs in the field of Health with a duration of 6 years must have fully passed the years I III of study...
- Students wishing to be admitted in the fourth or fifth year of the Pharmacy specialization must have fully completed the first, second and third years of study.
- For students in non-medical study programs with a duration of 3 years of study, who wish
 to be admitted in year II or III and II, III or IV in study programs with a duration of 4 years, the
 minimum number of credit units for the recognition of one year study is 30 transfer credit units
 awarded within the same study program delivered by another University.
- For the admission to a higher year from different academic study programs, but in the same field, the compatibility of curricula will be considered and the system of transfer credit units will be taken into account, the minimum number of credit units for the recognition of a year of study being of 45 for the programs within the Health field and 30 credit units for the other programs, according to the curricula of the study programs within the "Vasile Goldiş" Western University of Arad, provided that the obligation to pass wholly the entire cycle of studies is observed, for the programs in the field of Health.
